Select Free Tax Help on the IRS2Go app, or call 1-800-906-9887 to find the nearest location for free tax preparation. The military community may also use MilTax. Go to IRS.gov/TCE for free help with your taxes, or call 1-888-227-7669 to find the nearest location for free tax preparation Check to see if you're eligible for IRS Direct File, and file online directly with IRS for free. Use Direct Deposit when filing your return for a quicker refund. It's fast and safe.

Having trouble paying a tax bill in full	 Learn your options if you can't pay what you owe.
